

## FIRE EXTINGUISHERS

City and state law require the installation and maintenance of class ABC fire extinguishers to provide protection from fires fueled by combustible materials, flammable liquids and electrically charged equipment. In nearly all cases, extinguishers are required on each floor within 75' travel distance (50' in parking garages), and in specialty rooms such as those containing elevator machinery, a boiler or water heater, trash collection containers/dumpsters, or laundry facilities. Class K extinguishers are required in commercial kitchens.

### ANNUAL MAINTENANCE

City and state law requires that extinguishers receive annual examination by a licensed technician, with service properly documented.

### INSTALLATION

By law fire extinguishers are required to be installed in specified locations and installation must be performed by a licensed technician.

## FIRE EXTINGUISHER SECURITY CABINETS

Cabinets provide a clean, modern look and act as a deterrent against theft of your extinguishers. All cabinets are custom ordered.

### METAL CABINETS

Metal cabinets provide a clean, "high end" appearance that is a vast improvement over the look of an extinguisher attached directly to the wall. A cylinder lock and key protects the extinguisher and glass from tampering and theft. Each unit comes with an attached breaker bar used to break the glass in the case of a fire.

### POLYSTYRENE CABINETS

These cabinets are made from thick, molded plastic which provides a rust-proof, dent-proof and easy to clean surface. They use a plastic break panel instead of glass, which minimizes potential safety issues. Each comes with an attached hammer used to break the protective panel in the case of a fire. Access restricted by a cylinder lock and key.

## EMERGENCY/EXIT LIGHTING

Emergency/exit lighting fixtures with backup battery power must be inspected and certified annually in accordance with city and state law. Documentation of service and certification must be affixed to the unit as well as maintained in written records available for inspection for up to 10 years.

Chicago also mandates specific requirements for emergency lighting fixtures, such as prohibiting dry cell batteries and requiring the use of red lettering for exit signs.

## SMOKE AND CARBON MONOXIDE DETECTORS

City and state law require the installation of smoke detectors and/or carbon monoxide in certain common areas such as stairwells, basements and rooms with fossil fuel burning appliances. Detectors must be installed at specified heights/locations to meet code requirements and to function properly. Detectors expire after 7 - 10 years but due to environmental conditions often become inoperable prior to expiration.

Both the City of Chicago and the State of Illinois require that newly installed battery-operated detectors have a sealed, 10-year battery.
